- High school graduate, GED equivalent or NCRC Workkeys – Bronze level or higher

## **ON-THE-JOB TRAINING:**

Approximately 4,000 hours of On the Job Training are required to complete this program.

Roofers remove old roof and waterproof foundation walls. Commercial roofs are generally low-pitched roofs that consist of multiple layers of roofing applied with asphalt, plastic (TPO/PVC), or rubber (EPDM). Residential roofs are usually steep and the roofing material is mainly asphalt shingles, wood shake, slate or tile. Tools used include hatchets, hammers, pry bars, tin snips, knives and chalk lines.

Roofers work is performed in all weather conditions. Heights and roof structures vary. Roofers must be in good physical and mental condition to lift roofing materials, work in difficult weather, and perform detailed work with a good attitude. This work can be seasonal and there can be periods of unemployment.

While most jobs are within a 50-mile radius of the Portland/Vancouver Metro Area there may be some travel. An apprentice is expected to have reliable transportation to get to the jobsite and school.

All Roofers should expect to do a considerable amount of lifting thus strength, dexterity and alertness is required. As a supporter of other skilled craftsmen, Roofers' work requires that their skills be diversified. Roofers must have good math and reading skills to use today's highly technical tools and equipment.

## **RELATED TRAINING:**

A minimum of 156 hours per year of classroom training is required each year in the program. A minimum of 625 hours is required to complete this program.

## **WAGE SCHEDULE:**

Apprentice wages are based upon the average wage for journey workers employed by participating training employers. The journey wage as of **June 1, 2023 is \$33.00**. Apprentices are paid a progressive percentage of that average journey wage as follows:

1st 500 hour period	60% of average wage
2nd 500 hour period	65% of average wage
3rd 500 hour period	70% of average wage
4th 500 hour period	75% of average wage
5th 500 hour period	80% of average wage
6th 500 hour period	85% of average wage
7th 500 hour period	90% of average wage
8th 500 hour period	95% of average wage
