#### **MINIMUM QUALIFICATIONS:**

- 18 years of age (must provide proof of age)
- High School Diploma or GED
  - or: Completion of an Associated Degree or higher that is recognized by the Department of Education.
  - or: Test scores within 12 months on Alex, COMPASS or Accuplacer with placement at or above Math 20 or higher, Reading 115 or higher & Writing 101 or higher; or completion of the equivalent ABE course.
  - or: applicants who have completed 2,000 OJT hours, 1st year related training and are/were in good standing with a Laborers JATC may use experience to meet the education benchmark.

#### ALL APPLICANTS MUST ALSO:

- Pass a UA substance abuse test
- Complete a Trade Orientation (free of charge)
- Complete sponsor Construction Safety Training
- Complete sponsor Jump-Start (pre-construction) Training (free of charge)

#### ON-THE-JOB TRAINING:

Approximately 8,000 hours of on-the-job training are required for completion of apprenticeship. Carpenters apprentices will learn form building, pre-fabricated concrete installation, rough framing, outside finishing, inside finishing, acoustical and drywall, finish hardware, layout, care and use of tools and woodworking machinery, walkways and shed construction, safety and protection device construction, installation of pre-fabricated modules, and scaffolding.

#### RELATED TRAINING:

A minimum of 144 hours of classroom training is required each year to complete the program. This is broken up into three terms of one class per term. Classes are held at Northwest College of Construction in Portland, OR.

#### **WAGE SCHEDULE:**

Apprentice wages are based upon the average wage for journey workers employed by participating training employers. The journey worker wage as of June 1, 2023 is \$31.45/hr. Apprentices are paid a progressive percentage of that average journey wage as follows:

<b>1</b> st	1,000 hour period	60% of average wage
2 <sup>nd</sup>	1,000 hour period	65% of average wage
3 <sup>rd</sup>	1,000 hour period	70% of average wage
<b>4</b> th	1,000 hour period	75% of average wage
5 <sup>th</sup>	1,000 hour period	80% of average wage
6 <sup>th</sup>	1,000 hour period	85% of average wage
7 <sup>th</sup>	1,000 hour period	90% of average wage
8 <sup>th</sup>	1,000 hour period	95% of average wage
