REGISTRATION IS CURRENTLY CLOSED

MINIMUM QUALIFICATIONS:

- 18 years of age (Must provide proof of age)
- High School Diploma or GED
 - or:** Completion of an Associated Degree or higher that is recognized by the Department of Education
 - or:** Test scores within 12 months on Alex, COMPASS or Accuplacer with placement at or above Math 20 or higher, Reading 115 or higher & Writing 101 or higher; or completion of the equivalent ABE course
 - or:** Education Substitution: applicant in good standing with 2,000 OJT hours, 1st year training and good standing with a Laborers JATC may be substituted in lieu of a High School Diploma or GED

ALL APPLICANTS MUST ALSO:

- Complete a Trade Orientation (free of charge)
- Complete sponsor Construction Safety Training (free of charge)
- Complete an interview with the committee

NOTES:

- Employment opportunities are subject to economic conditions
- Selection will be based on an applicant ranking system
- Employers may require a valid driver's license and drug test
- VETERANS who have GI Benefits may use them in this program
- Graduates of a BOLI-approved Pre-Apprenticeship Program are encouraged to use this program

- Lane and Douglas Counties

ON-THE-JOB TRAINING:

Approximately 8,000 hours of on-the-job training are required for completion of apprenticeship.

Carpenter apprentices will learn form building, pre-fabricated concrete installation, rough framing, outside finishing, inside finishing, acoustical and drywall, finish hardware, layout, care and use of tools and woodworking machinery, walkways and shed construction, safety and protection device construction, installation of pre-fabricated modules, and scaffolding.

RELATED TRAINING:

A minimum of 144 hours of classroom training is required each year to complete the program. Classes are held at Northwest College of Construction in Portland, OR.

WAGE SCHEDULE:

Apprentice wages are based upon the average wage for journey workers employed by participating training employers. The journey worker wage as of June 1, 2025, is \$35.00. Apprentices are paid a progressive percentage of that average journey wage as follows:

1 st	1,000-hour period	55% of average wage
2 nd	1,000-hour period	60% of average wage
3 rd	1,000-hour period	65% of average wage
4 th	1,000-hour period	70% of average wage
5 th	1,000-hour period	76% of average wage
6 th	1,000-hour period	82% of average wage
7 th	1,000-hour period	88% of average wage
8 th	1,000-hour period	95% of average wage
